On 9 July 2021, Jee Up Enterprises Limited acquired all of Yun Sheng Capital Cayman's interests in the Fund.

The investment committee of the Fund comprises a representative from the fund manager and a representative from each of its two investors, Kung Chak Ming and Jee Up Enterprises Limited. Accordingly, Jee Up Enterprises Limited has control over the business and affairs of the Fund, including making investment and divestment decisions and voting the securities and interests held by the Fund, including those in the Listed Issuer. Huang Bohao is the sole shareholder of Jee Up Enterprises Limited. It is therefore deemed to have an interest in the Shares held by the Fund in the Listed Issuer, pursuant to s 4 of the SFA.
